 - i. The first meeting of the book club was a success. The October meeting will be held in Deep River Town Hall. Finding meeting locations in Essex and Chester continues to be hard because facilities charge fees for meeting space.

 - i. The food scrap collection contact is under review by the town lawyer. The cost of the program is \$230/month. The committee discussed ways to promote the program when it is launched. Molly suggested that the Committee create a publicity check list that we can use when we promote all of our activities. Lenore mentioned the \$5million grant from the State of CT for garbage reduction. Letters of intent are due by Oct. 29. Jonathan and Joyce have been tasked with taking care of the grant submission by Angus.
- f. 2.3 Inventory and Promote Local Retail Options (Carol Jones)

i. Carol distributed copies of a business index brochure produced by the

Deep River Merchant and Business Association several years ago.

Jonathan Kastner and Michelle Giddens will coordinate with the

association to update the index. Molly Flueckiger mentioned that we

can get 5 points for a list and 5 points for a map. We can also get

credit for including special designations.
