APPLICATION PROCEDURES FOR OBTAINING INDIVIDUAL NON-COMMERCIAL MOORING PERMITS:

- Permit Applications should be submitted to the Town Clerk's Office or mailed to the Harbormaster (address shown above) **no later than April 15th**.
- One copy of your Certificate of Insurance is required to be submitted with your application.
- Mooring permits do not carry with them guaranteed or implied permanence from year to year. The Harbormaster or Deputy Harbormaster may require the relocation of moorings to provide more efficient use of the limited available space.
- Only the <u>Harbormaster</u> or his <u>Deputy Harbormaster</u> may issue mooring permits and assign a mooring space. The Harbormaster or Deputy Harbormaster must be present to approve your mooring location installation.
- Mooring Permits shall be issued only to applicants owning a vessel properly registered in accordance with the laws of the State of Connecticut.
- Mooring Permits are valid for a period of <u>one year</u> and will be valid from March 15th through December 1st and are not transferable to another party.
- <u>Mooring Specifications must meet or exceed attached "Minimum Standards for Single Point</u> <u>Mooring". If your mooring ball is not marked per mooring specifications you may lose your mooring</u> <u>tackle. We have no way to identify unmarked moorings. Unmarked moorings will be removed at the</u> <u>owner's expense or, if the owner cannot be found, the mooring will be sold to cover the cost of</u> <u>removal.</u>
- Moorings must be placed and set by May 31st or you may lose your space and permit for the season.
- <u>Note:</u> No standards or inspection requirements can ensure vessel security for all possible conditions. The Town of Deep River and the Harbormaster or Deputy Harbormaster <u>do not</u> assume any responsibility for personal injury or property damage that may result from the use of any mooring tackle that meets or exceeds the minimum standards. <u>Mooring tackle must be inspected yearly.</u>
- Moorings must be removed <u>every year</u> by December 1st. Any mooring <u>not</u> removed by December 1st will be considered abandoned and subject to removal or relocation by the Harbormaster or Deputy Harbormaster <u>at</u> <u>the expense of such registered owner.</u>

- For the purpose of loading and unloading vessels, the Town of Deep River has a 2 hour docking limit on the main fixed dock and a 15 minute docking limit on the floating docks.
- If you have a valid mooring permit and you do not utilize said space with the vessel as stated on your application, your mooring will be subject to removal at your expense, per order of the Harbormaster or Deputy Harbormaster.
- A permit holder wishing to allow another boater to use his mooring space for a maximum of 30 days shall inform the Harbormaster or Deputy Harbormaster in writing with the following information: visiting vessel's name, length and draft, registration information, owner's name, address and phone number. The Harbormaster or Deputy Harbormaster shall approve or disapprove such request.
- If you have been approved for a mooring permit and cannot use or do not want your assigned space for the current season, please notify the Harbormaster or his assistant as soon as possible. We have limited mooring spaces and a waiting list for spaces. Thank you for your consideration.

PARKING FEE REQUIREMENTS AT THE DEEP RIVER LANDING:

No large box trucks or buses are allowed to park at the landing.

<u>Non-Residents are now required to purchase a Seasonal Parking Pass</u> <u>in order to obtain a mooring permit.</u>

This pass is good from March 15th to December 1st and costs \$300.00.

Residents with a valid Town sticker may park at no charge.

All parking passes and stickers may be obtained from the Town Clerk Monday through Wednesday from 9:00-4:00, Thursday from 9:00-6:30, and Friday from 9:00-noon.
